<u>Get laptops and tablets for pupils and students</u> who cannot access face-to-face education due to coronavirus (COVID-19) – Updated 17<sup>th</sup> February

This guidance sets out how schools, 16 to 19 academies, colleges, and other further education institutions, can access digital devices for pupils and students learning remotely. It has been updated to clarify who is eligible for devices. This includes when devices are available for children in reception, year 1 and year 2, and students over the age of 19 with an education, health and care plan (EHCP) who also receive free meals.
